Additional Technical Advice

In addition, depending upon the nature and scale of the development proposal, comprehensive pre-application advice may require input from other functions within the County Council and also for Noise and Air Quality. Applicants for Suffolk County Council's Planning Pre-application Advice Service can include additional services from as additions to the overall fee.

Archaeology

Currently, the archaeology service only charges for pre-application advice for complex sites on a case-by-case basis. Further charges are required for reviewing documents associated with discharge of conditions for example.

Floods & Water Management

Minor projects are unlikely to require professional input from the County Council's Flood & Water Management Team. The following table sets out the likely fees for advice from the Floods and Water Management team:

Highways & Transport

Given the often variation and complexity of the impact of major and large-scale minerals or waste projects on the highway network, a quotation for advice would be provided if requested.

For minor projects, where only a written response from a Highway Officer is required, the optional fee would be £180 plus VAT.

Noise and Air Quality

Advice from the County Council's noise and air quality consultants, SRL Technical Services Limited, is likely to be needed for minerals and waste developments to set out the necessary methodology and potential mitigation options. A quote can be provided and, if taken up, this cost will be recharged to the applicant.

Other Statutory Consultees

Advice may also be required from other statutory consultees such as the Environment Agency, Natural England and Historic England. This advice should be sought separately as these agencies' own pre-application charging schedules will apply.
