

Suffolk County Council meeting Thursday 3 December 2020, vote taken on Motion 3

Motion 3 – Proposed by Councillor Jack Abbott and seconded by Councillor Sarah Adams.

Motion Text: 'This council believes that every person delivering services on behalf of Suffolk County Council, whether they are directly or indirectly contracted, deserves to be compensated with a fair salary that, as an absolute minimum, meets the costs of everyday living.

It should be welcomed that Suffolk County Council pays almost all its own staff a Real Living Wage (RLW), which increases each year in line with rates set out by the Living Wage Foundation. However, with almost a quarter of jobs in Suffolk paying less than the RLW¹, it is clear that Suffolk County Council should look to extend this commitment to their contractors.

Research shows the RLW benefits business and benefits society² - this has already been recognised by the dozens of employers across Ipswich and Suffolk that are RLW accredited. Working with these employers, including Ipswich Borough Council, Suffolk County Council can build a coalition of local organisations, from public, private and the third sector, to drive the uptake of the Living Wage in Ipswich and create a Living Wage Town³. This can then be extended to the whole of the county.

Earlier this year Suffolk County Council unanimously agreed to tackle food poverty paying people a RLW is an important step forward in doing so. Many of Suffolk County Council's staff, employed directly and indirectly, have been on the front line throughout this pandemic. We must ensure those who have bravely served our residents and our communities are at least paid enough to meet the cost of living.

Therefore, this council resolves to:

- 1. Recognise Suffolk County Council's commitment to paying the Real Living Wage by seeking accreditation as a Living Wage Employer through the Living Wage Foundation;
- 2. Move towards a Living Wage Employer accreditation guarantee, by ensuring that that all cleaning and catering staff working in Suffolk County Council buildings are paid the Real Living Wage from April 2021;
- 3. Encourage existing contractors to adopt the Real Living Wage, and include a Real Living Wage clause in all new contracts from April 2022;
- 4. Work with Ipswich Borough Council and other partners to establish a Living Wage Town action group for Ipswich, with a view to extending this throughout the county.
