MIS PROCUREMENT UPDATE

FOR LA MAINTAINED SCHOOLS

Following the article in the November newsletter, we have completed the initial supplier demos.

We included a group of LA maintained schools who were recommended by our colleagues from CYP. But we would like to make these demos available to all LA maintained schools who wish to view them and provide feedback. Several schools as a cross representation of our LA Schools community are now engaged in more detailed requirements capture, as the next step in the procurement process.

If you would like a copy of the recordings, please contact <u>Andrew.brown2@suffolk.gov.uk</u> by 22/12/2023. The recording can only be shared with people who have a school mail address, we are unable to send these to private email accounts.

Once viewed please provide your questions, feedback and any specific requirements by 26/01/2024 so we can collate these responses for the next stage of the procurement process.

Although our contract with SIMS and FMS doesn't run out until 31st March 2025, this is a major piece of work, and we are unable to move the project completion date. We recognise our tight deadlines may not work for everyone, so although your participation is recommended, it is not essential to help us choose a new MIS and finance supplier for our LA maintained schools.

As a local authority our procurement process is tightly regulated, so we would ask schools not to contact potential suppliers directly or speculate on the outcome at this stage of the process.

SIMS and FMS 2023 AUTUMN RELEASE

We are pleased to inform you that the Autumn 2023 upgrade for SIMS. net and FMS has been released on 15/11/23. This will be downloaded and applied via SOLUS3.

Preparation for Next Census - 18th January 2024

You may have read the release notes for the Autumn upgrade that brings Sims .Net to version 7.214; a link to this can be obtained from the Useful Information section.

Please ensure that you prepare for this and perform a dry run before census date to remedy as many queries and errors as possible. Documentation can be obtained from the ESS statutory returns link within the Useful Information section below.

School Census Spring 2024 Key Dates:

- Census day 18/01/2024
- Attendance collected from 01/09/2023 to 31/12/2023
- Exclusions collected from 10/04/2023 to 31/12/2023
- Alternative Provision Placements collected from 05/10/2023 to 18/01/2024
- Funding and Monitoring collected from 01/08/2023 to 18/01/2024
- Free School Meal Eligibility collected from 06/10/2023 to 18/01/2024

Please remember that free school meals do not have an end date, if a pupil has qualified then they do not need to re-apply until at least the Summer of 2025.

"Transitional protections were initially enacted with an end date of March 2022, the date the rollout of Universal Credit was due to end. When the end date moved to March 2023 the Government extended the protections in line with this date. As the rollout is continuing, the end date for transitional protections is being further extended to March 2025."
