The proposed governance model:

- Establishes robust, accountable decision making along with overview and scrutiny and audit arrangements.

- Engages relevant local stakeholders either as non-constituent or associate members or through direct engagement by the Mayor with local stakeholders and residents.
- Will develop, champion and implement a strategic vision for Suffolk and Norfolk and advocate for the Eastern region, working with established MCA and new MCCAs across the East.
- Enables work with local partners from across communities, businesses and other key sectors e.g., Voluntary, Community, Faith and Social Enterprises; education; the NHS; community safety and criminal justice.

#### Please explain your answer:

- The MCCA will enhance many key sectors that Suffolk and Norfolk share. These include: agri-food and technology; clean energy; ports and logistics; ICT and thriving visitor economies due to their strength of cultural, heritage and natural assets.
- It builds on established collaboration between Suffolk and Norfolk for economic development.
- The proposed MCCA brings additional funding, powers and national influence that will enhance the area's significant economic potential and contribute to this government's growth mission.
- Both large geographical counties, Suffolk and Norfolk need better physical and digital infrastructure to unlock economic growth and keep communities and businesses connected.

- The MCCA's additional powers, funding and devolved decision-making offers opportunities to improve skills, reduce barriers to access employment, tackle inequalities, deliver affordable housing and improve accessibility (physical and digital).
- Through its membership, partners and engagement, the MCCA will be informed by local insight and data (e.g., Suffolk's and Norfolk's Offices of Data Analytics). This will enable action to be targeted to deliver the best outcomes.
- The MCCA will be able to convene key partners to develop ways to tackle systemic inequalities and diverse needs, e.g., ways to help people be more confident to access work and tailoring skills provision to meet local needs.

- Brings additional investment that can be more tailored to local need and characteristics and reduces competitive bidding to central pots. Therefore, providing more effective and efficient use of the funding.
- Offers longer term funding and investment that enables better planned and more effective delivery.
- Provides additional democratic representation for Suffolk and Norfolk at a regional level that will also need to be connected to local communities.

## Please explain your answer:

- Improving the natural environment is a priority in Suffolk and Norfolk. There already exists a Norfolk and Suffolk Nature Recovery Partnership that leads the Local Nature Recovery Strategy across the counties. It work is informed by the joint evidence base in the Norfolk and Suffolk Natural Capital Compendium.
- There are significant natural landscapes shared across Suffolk and Norfolk e.g., the Brecks, the Broads and their coastline.
- The MCCA will be an advocate for the counties' natural assets helping protect and improve them. This will also support sustainable tourism, an important economic contributor to the area.
- More broadly, work to tackle climate change is also a priority for Suffolk and Norfolk. Therefore, the MCCA's national influence can help support and augment existing local work as well as contributing to national targets. (853 characters with spaces)

#### Please explain your answer:

- Suffolk and Norfolk have rural, coastal, market towns and larger urban communities. Their needs are often overlooked at national level leading to underfunding and missed opportunities.
- The MCCA's devolved decision making, funding and powers will better meet those needs with its local insight and community connections. This could include cultural and heritage projects that promote local identity.
- The MCCA will champion local communities at national level, representing their characteristics, offers and needs. For example, the counties are collaborating on NSIPs across our communities.
- The MCCA's members, particularly the constituent members, will support its understanding and connection to local communities of place and people.
- Community engagement will be an important part of the business cases that Suffolk and Norfolk County Councils are developing for local government reorganisation, e.g., working with town and parish councils and other community organisations.
