The Suffolk Economy



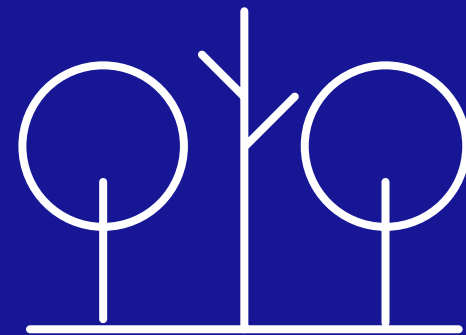
- Amongst the highest productivity in the UK outside of London

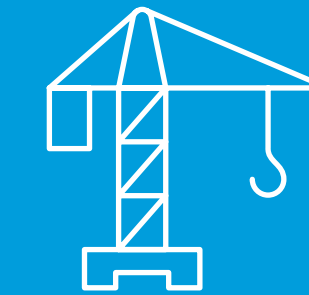

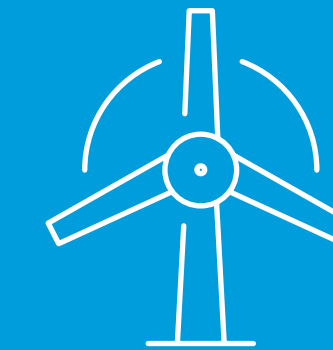

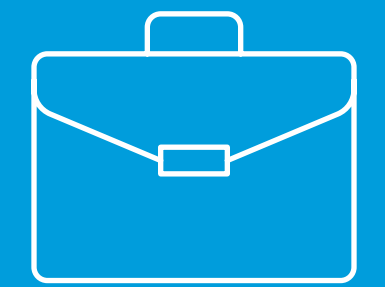
