Adult Social Care (ASC) recently carried out a procurement exercise only available to providers on the Locality Home Care Framework for "External Reablement". This additional service is designed to add capacity to the Home First reablement offer.

Home First will work in partnership with the External Reablement providers to ensure as many service users as possible have a chance to regain their independence.

The procurement has now been completed and all providers who submitted a bid have been informed of the outcomes. External Reablement will go live from **Monday 28th April 2025**.

The Locality Home Care framework process for bidding, accepting and starting long term home care packages remains unchanged.
