# **Emollients and Fire Safety Webinars**

We have unfortunately seen multiple instances of harm, serious injury and death from fire, where emollients are believed to be a factor.

Multiple colleagues from different specialities in the Norfolk and Waveney System have been working hard to put together multiple measures to improve care in this area. One part of this has been developing a webinar to improve the knowledge and understanding of:

- What emollients are and why they pose a fire risk
- Who is at risk of injury and serious harm and why
- What the latest research says
- Personal risk assessments and care planning
- What can we do to better protect and support people

This webinar is aimed at any and all health and social care colleagues as well as family and/or parent carers. We will be running 6 sessions across 3 weeks which occur on different days and at different times to try and maximise the opportunities for people to attend. NCPS's counsellors have signed up to help registered managers find ways to cope with any and all issues they are facing, to find balance in their personal and work lives, and to find their way through stress, anxiety, depression, grief or burnout – whether or not it's related to their job.

These types of services are sometimes offered through workplace Occupational Health services therefore, this may prove to be very useful for smaller providers without a dedicated Occupational Health service, and it's being provided at a discount rate.
