Name Change for Service Development & Contracts

As part of the recent Staff Consultation, we took the opportunity to review our team names and have made a few changes which are set out below.

Our whole service will now be known as Strategic Commissioning & Contract Management (SCCM) – it was previously Service Development & Contracts.

There are eight teams in total – 3 based in the localities and 5 county wide teams based in Endeavour House. The 3 Locality teams will be known as:-

- Strategic Commissioning & Contract Management Ipswich & East
- Strategic Commissioning & Contract Management West
- Strategic Commissioning & Contract Management Waveney

The 5 county-wide teams are collectively known as Strategic Planning & Resource (SPAR) and we will retain this name. The individual teams that make up SPAR are as follows:-

- Supported Housing & Day Opportunities (SHADO)
- Care Market Hub (Formally ASC Contracts Helpdesk)
- Home Care & Brokerage
- Early Intervention & Prevention
- Residential & Nursing Care Homes (RANCH)

Review of CQC Regulation 9A

As you may be aware, DHSC are currently conducting a review into the effectiveness of Care Quality Commission (CQC) Regulation 9A: Visiting and accompanying.

Regulation 9A requires care homes, hospitals and hospices to facilitate visits into, and out of, the setting, and facilitate accompanying by family and friends to outpatient appointments, unless there are exceptional circumstances.

On Wednesday 28 May, DHSC launched a <u>call for evidence seeking views and experiences of visiting and</u> <u>accompanying in care homes, hospitals and hospices</u>. The survey will be open for 6 weeks, closing at 11:59 on 9 July.

In addition, DHSC will be running focus groups to explore the impact of Regulation 9A, experiences around visiting and accompanying, and how Regulation 9A could be more effective. These themes will guide conversations, but DHSC are also keen to delve deeper into any areas that emerge during the discussion.

All focus groups will last approximately two hours and will be held remotely, over Microsoft Teams, with representatives from DHSC, CQC, and UKHSA. As well as conducting targeted focus groups, DHSC will conduct a mixed focus group which will be an opportunity for individual and professional participants to discuss together.

The focus group dates will be as follows:

- Tuesday 24th June (10:30-12:30) Provider representatives and registered managers
- Friday 27th June (10:30-12:30) Advocate and charity representatives
- Tuesday 1st July (10:30-12:30) Care home staff members
- Thursday 3rd July (10:30-12:30) Care home residents or their family members or supporters
- Tuesday 8th July (10:30-12:30) Health experts, including representatives from Local Health Protection Teams, Local Resilience Forums, Directors of Public Health, ADASS, members of ICBs, UKHSA, and CQC
- Thursday 10th July (10:30-12:30) Mixed ASC audience, including representatives from all the above groups
