

## Suffolk County Council meeting Thursday 10 July 2025, vote taken on Motion 3 as amended.

Motion 3 – Proposed by Councillor Sandy Martin and seconded by Councillor Rob Bridgeman.

Motion Text: Recognising the severe congestion caused by the current programme of partial closures of the Orwell Bridge, and the cost to the entire Suffolk economy, including the disruption to freight from Felixstowe, this County Council hereby commits to:

- 1) Affirming its resolve that a Northern Bypass (Ipswich Northern Route / INR) for other interventions for Ipswich should be built, to relieve traffic congestion in North Ipswich and in the villages north of Ipswich, and to provide an alternative for the A14 when the Orwell Bridge is not fully operational
- 2) Re-examining the work that has already been done to determine the best possible route for a Northern Bypass for Ipswich
- 3) Seek from government clarification that the Ely and Haughley rail junction improvements, the A12 Major Road Network (MRN) scheme, Fiveways interchange on the A11, and Copdock interchange on the A14 remain funding priorities and that the A12 Major Road Network (MRN) scheme is fully funded following the recent announcement.
- 4) Establish where the INR, if a funding priority for government, sits within this list of priorities.
- 5) Request clarification from the government if additional housing in the region of 15,000 homes, over and above existing allocations, is still required for delivery of the INR 2)
- 6) Write to the leaders of East Suffolk District Council and Mid Suffolk District Council asking what additional housing over existing allocations they would be prepared to deliver to facilitate an INR
- 7) Working with the MPs for Ipswich, Suffolk Coastal, and Central Suffolk and North Ipswich, and South Suffolk, to build a consensus for the way ahead, and to present a united case to the Department for Transport. 3)
- 8) Recognise that the new Mayor of Suffolk and Norfolk will have a key role in any business case for the INR.
