# **Register of Members' Interests**

The name of any person from whom you have received a gift or hospitality with an estimated value of at least £50 (received within the last 28 days).	Declarations of gifts and hospitality are recorded separately but constitute part of the Register of Interests.

- (2) provide information that is materially false or misleading;
- (3) fail to give further notices in order to bring up to date information given in this notice after my reelection or reappointment or to fail to declare a disclosable pecuniary interest that I acquire after the date of this notice and have to declare under the provisions of s. 31 (2) Localism Act 2011.

I also acknowledge that it may be a breach of the Code of Conduct to:-

- (1) omit information that ought to be given in this notice;
- (2) provide information that is materially false or misleading;
- (3) fail to provide written notification to the Council's Monitoring Officer of any change in my interests contained in this notice within 28 days of my becoming aware of such change of circumstances.
