Suffolk County Council's (SCC) County Children with Disabilities Service (CCwDS), delivers targeted and specialist support underpinned by assessed need focused on targeted and specialist packages of support including short breaks via direct payments.

These can be paid into bank accounts or as part of a support plan.

Suffolk County Council grant funds and has contracts in place with some overnight short break providers which offer overnight short break provision for children with disabilities. These are managed by Activities Unlimited on behalf of Suffolk County Council and payments are made direct to the provider.

SCC will broker and fund a support service for the direct payment recipient depending on the support needed to manage their direct payment.

This may include support for recruiting personal assistants, payroll services, general employment support services, money holding services.

The main providers SCC work with are :

- The Rowan Organisation.
