

Environmental Information Regulations – Response - 26761

I am writing to make a request for information under the Freedom of Information Act 2000. Suffolk County Council guidance on highway and footway maintenance refers to the use of a matrix or hierarchy to prioritise inspection, maintenance and repair of footways and carriageways.

I would be grateful if you could provide the following information:

- 1. The current maintenance classification, hierarchy level or grading applied to each adopted road and footway within the area shown by the broken red line on the attached map.*
