Please also note, under its delegated powers, West Suffolk Council may suspend parking controls (including waiting, parking, and loading restrictions) on permit parking bays, limited waiting bays and pay-and-display bays. West Suffolk Council may therefore hold additional information for the streets in the area specified.

Redacted Information

All information released in response to a Freedom of Information Act 2000 (FOIA) or Environmental Information Regulation 2004 (EIR) request is deemed to be in the public

domain. As such we must consider whether or not the requested information qualifies as personal information and should therefore not be released into the public domain.

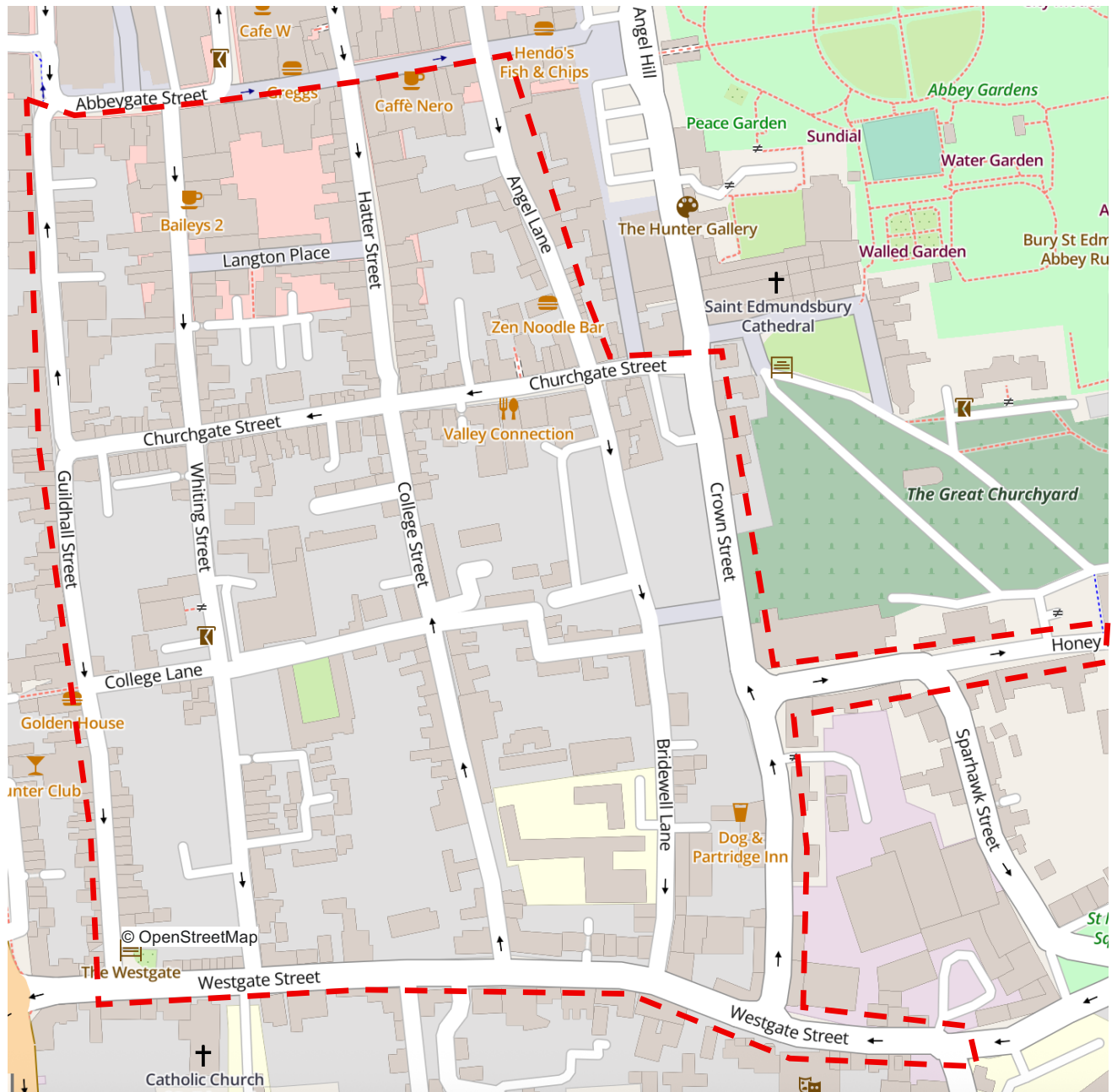
The council has determined that this is personal information and is therefore exempt from disclosure under **section 40** of the FOIA and **regulation 13** of the EIR.

The Council considered the following, including the possible consequences of disclosure for the data subjects concerned and their reasonable expectations as to the use of their data:

- expectations of the individuals concerned about personal information being put into the public domain;
- reasonable expectations - the data subjects concerned would have a legitimate expectation of privacy concerning their personal information and would not have anticipated this being put into the public domain;
- whether or not the requested information could be anonymised; and
- balancing the individual's rights and the legitimate interests - In past cases the Information Commissioner has weighed the individual's rights to privacy against the public interest in disclosure. There is no presumption in favour of releasing personal data.

This is an absolute exemption, which means that if the condition is satisfied there is no additional public interest test to consider.

In assessing fairness, the Council considered the likely consequences of disclosure of the requested information. Personal information should not be used in ways that have unjustified adverse effects on the individuals concerned. The council also considered whether such disclosure would be within the reasonable expectations of the individuals, given that any response to a request under the FOIA or EIR is deemed to be in the public domain. The council believes that in this instance it is not fair to disclose personal data and is therefore withholding the requested information under section 40 of the FOIA and regulation 13 of the EIR.

WHEREAS Suffolk County Council ('the Council') being the highway authority for the roads specified in this Order, is satisfied that traffic on the said roads should be restricted to enable West Suffolk County to hold the VJ Day Commemoration (hereinafter referred to as 'the event').

NOW, THEREFORE, the Council in exercise of its powers under Section 16A(2) of the Road Traffic Regulation Act 1984, as amended by the Road Traffic Regulation (Special Events) Act 1994 and of all other enabling powers, hereby makes the following Order:

1. The provisions of this order will operate as and when required at the discretion of the police and event organisers.
2. Except as provided in Articles 3, 4 or 5, no person shall, except upon the direction or with the permission of a police constable in uniform, a police community support officer or a civil parking enforcement officer, cause or permit any [motor] vehicle to proceed in Angel Hill.
3. Nothing in Article 2 of this Order shall make it unlawful for a person to cause or permit any [motor] vehicle to proceed in the length of road referred to in that Article if the vehicle is taking part in the event in an official capacity.
4. Nothing in Article 2 of this Order shall make it unlawful for a person to cause or permit any [motor] vehicle to proceed in the length of road specified in that Article if the persons [and vehicles] taking part in the event have passed and a police constable in uniform or anyone acting with his authority has removed the signing.
5. (1) Insofar as safe passage permits, nothing in Article 2 of this Order shall make it unlawful for a person to cause any [motor] vehicle to enter or proceed in the length of road referred to in that Article in order to gain access to or egress from premises adjacent to or accessible only from that length of road.

(2) Nothing in Article 2 of this Order shall make it unlawful for a person to cause or permit any vehicle to proceed in the lengths of road specified in this Order if the vehicle:
 - (i) is to be used for police operational, fire brigade or ambulance purposes;
 - (ii) cannot conveniently be used for such purpose in any other road and is to be used in an emergency in connection with any of the following operations, namely: the laying, erection, alteration or repair in or on land adjacent to the said length of road of any sewer or of any main, pipe or apparatus for the supply of gas, water or electricity or of any telecommunications system as defined in the Telecommunications Act 1984;
6. No person shall, except upon the direction or with the permission of a police constable in uniform, a police community support officer or a civil parking enforcement officer, cause or permit any vehicle to wait at any time on the lengths of road specified in this Order.
7. During the period of operation of this order, SUFFOLK COUNTY COUNCIL (BOROUGH OF ST EDMUNDSBURY) (STOPPING, WAITING AND LOADING PROHIBITIONS AND RESTRICTIONS AND ON STREET PARKING PLACES) (MAP BASED) ORDER 2025 , shall be suspended insofar as it relates to parking on Angel Hill.
8. This Order is made on condition that West Suffolk Council will:

- a) advise all residents and businesses affected by the closure of the aforesaid road or roads;
 - b) keep the local police informed of all proceedings related to the event;
 - c) indemnify the Council from and against all legal liability in respect of loss, damage, actions, proceedings, suits, claims, demands, costs, damages, liability and expenses in respect of any injury to or death of any person or destruction of or damage to any property (whether movable or immovable) by reason of or arising in any way directly or indirectly from the holding of the event;
 - d) reinstate and make good to the satisfaction of the Council any damage caused as a result of the holding of the event; and
 - e) pay to the Council a fee for legal and administration costs as shall be agreed with the Council.
9. Nothing in this Order shall prevent access by vehicles being used for police operational, fire brigade or ambulance purposes.
10. This Order shall be operative on *date* and shall continue in force for a maximum period of 3 days (unless extended by the Secretary of State). It may be cited as the Suffolk County Council (PARISH OF BURY ST EDMUNDS) (ANGEL HILL) (TEMPORARY CLOSURE AND TEMPORARY PROHIBITION OF WAITING AND SUSPENSION FOR A SPECIAL EVENT) ORDER 2025.

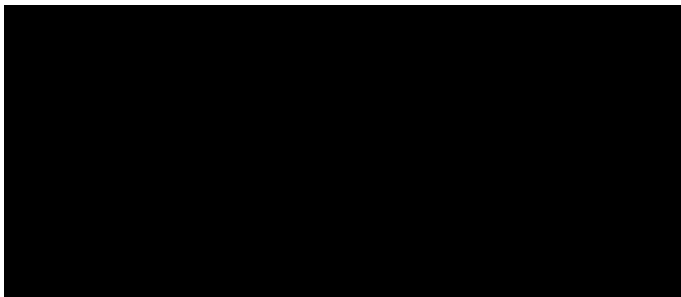

- b) The Borough of St Edmundsbury (Parish of Bury St Edmunds) (Angel Hill) (Prohibition and Restriction of Waiting and Loading and Revocation) (Street Parking Places and Bus Stop Clearway) Order 2001 (Variation) Order 2002 in so far as it imposes measures controlling waiting in Angel Hill.

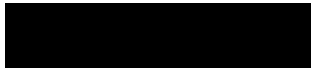
