

NOTICE OF CONFIRMATION OF PUBLIC PATH ORDER

TOWN AND COUNTRY PLANNING ACT 1990, SECTION 257 AND PARAGRAPH 7 OF SCHEDULE 14

EAST SUFFOLK COUNCIL (FELIXSTOWE FOOTPATH NO 28 (PART)) PUBLIC PATH STOPPING UP ORDER 2022

On 10 February 2023 East Suffolk Council confirmed the above order.

The effect of the order will be to stop up (extinguish) the entire width of that part of Felixstowe Footpath No 28 running from High Street to Candlet Road commencing at Ordnance Survey grid reference (OSGR) TM29093591 at High Street and proceeding in a north north easterly direction for approximately 308 metres to join Candlet Road at OSGR TM29203620 and create a new footpath commencing at OSGR TM28973597 at High Street and proceeding in a generally northerly direction for approximately 41 metres alongside the new roundabout junction to OSGR TM28973601 then crossing the spine road via a signalised crossing in a north westerly direction for approximately 17 metres to OSGR TM28963602 then in a generally north easterly direction along the western side of the spine road, crossing an estate road after 30 metres at OSGR TM28973604 and crossing an estate road after another 185 metres at OSGR TM29113615 continuing on for another 133 metres to OSGR TM29203621 to join A154 road (Candlet Road); as described in the order and as shown on the order map.

A copy of the order as confirmed and the order map have been placed and may be seen free of charge at Felixstowe Library, Crescent Road, Felixstowe, IP11 7BY between the hours of 10am and 4pm on Sunday and Monday, 9am and 5:30pm Tuesday, Thursday and Friday, Wednesday between 9am and 7:30pm and Saturday from 9am to 5pm. The order comes into force on the date on which East Suffolk Council certifies that the alternative highway has been created to its reasonable satisfaction, but if any person aggrieved by the order desires to question its validity or that of any provision contained in it on the ground that it is not within the powers of the above Act, or on the ground that any requirement of that Act, or any regulation made under it has not been complied with in relation to the confirmation of the order he or she may apply to the High Court for any of these purposes under Section 287 of the Town and Country Planning Act 1990 within 6 weeks from the date on which notice is first published as required by paragraph 7 of Schedule 14 to that Act.

PUBLIC PATH STOPPING UP ORDER 2022

This order is made by East Suffolk Council under section 257 of the Town and Country Planning Act 1990 ("the 1990 Act") because it is satisfied that it is necessary to stop up the footpath to which this order relates in order to enable development to be carried out in accordance with planning permission granted under Part III of the Town and Country Planning Act 1990 namely: DC/21/1322/ARM | Approval of reserved matters (layout, scale, appearance and landscaping) on DC/16/2778/OUT: Hybrid application seeking outline planning permission for demolition of existing buildings and phased construction of up to 385 dwellings, associated infrastructure, new public open space and a new link road and linear park between Walton High Street and Candlet Road with all matters reserved except access and full planning permission and listed building consent for demolition of existing buildings and conversion of curtilage listed stables to B1 business use, associated infrastructure and enhancements to the curtilage of 362 High Street - Land North Of Walton High Street Felixstowe Suffolk

BY THIS ORDER:

1. The footpath over the land shown by a bold black line on the attached map between points A – B and described in Part I of the Schedule to this order ("the Schedule") shall be stopped up as provided below.
2. There shall be created to the reasonable satisfaction of East Suffolk Council an alternative highway for use as a replacement for the said footpath as provided in Part 2 of the Schedule and shown by bold black dashes on the attached map between points C – D – E – F – G – H .
3. The stopping up of the footpath shall have effect on the date on which East Suffolk Council certifies that the terms of Article 2 have been complied with.
4. The following works shall be carried out in relation to the highway described

in Part 2 of the Schedule hereto, that is to say: The developer shall provide the footpath in accordance with the Certificate of Works issued by Suffolk County Council on 3 October 2022.

5. Bloor Homes Ltd are hereby required to pay the cost of carrying out the necessary works.

PART 1

DESCRIPTION OF SITE OF EXISTING FOOTPATH

Felixstowe Footpath No 28(part) – The entire width of that part of Felixstowe Footpath No 28 commencing at Ordnance Survey grid reference TM29093591 at the C370 road (High Street) at point A and proceeding in a north north easterly direction for approximately 308 metres to the A154 road (Candlet Road) at Ordnance Survey grid reference TM29203620 at point B; this being the route shown between points A – B on the order map.

PART 2

DESCRIPTION OF SITE OF ALTERNATIVE HIGHWAY

Felixstowe Footpath No 28(part) – Commencing at Ordnance Survey grid reference TM28973597 at the C370 road (High Street) at point C and proceeding in a generally northerly direction for approximately 41 metres alongside the new roundabout junction to point D at Ordnance Survey grid reference TM28973601 then crossing the spine road via a signalised crossing in a north westerly direction for approximately 17 metres to Ordnance Survey grid reference TM28963602 at point E then in a generally north easterly direction along the western side of the spine road, crossing an estate road after 30 metres at Ordnance Survey grid reference TM28973604 at point F and crossing another estate road after a further 185 metres at Ordnance Survey grid reference TM29113615 at point G then continuing for another 133 metres to join the A154 road (Candlet Road) at point H at Ordnance Survey grid reference TM29203621 this being the route shown between points C – D – E – F – G – H on the order map.

Width: 3.5 metres
