

SUFFOLK COUNTY COUNCIL (BOROUGH OF ST EDMUNDSBURY) (STOPPING, WAITING AND LOADING PROHIBITIONS AND RESTRICTIONS AND ON-STREET PARKING PLACES) (MAP-BASED) ORDER 2019 (BURY ST EDMUNDS) (4U1557 KEMPSON WAY AND C769 SKYLINER WAY) (PROHIBITION OF WAITING) (VARIATION NO. 15) ORDER 202-

Suffolk County Council proposes to make the above order under Sections 1, 2 and 4 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, which would incorporate revision 0 of Map Tile ED68 into the above-named 2019 Order, as amended and revision 1 of Map Tiles bearing references EB68, EC67 and EC68 shall replace revision 0 of the Map Tiles bearing the same references. The effect of this will be to introduce new 'No Waiting at Any Time' on:

- Both sides of Skyliner Way from its roundabout junction with Lady Miriam Way and Rougham Tower Avenue, to its southern point of termination, approximately 120 metres south of its roundabout junction with Kempson Way and Fortress Way.
- Both sides of Kempson Way from its roundabout junction with Skyliner Way and Fortress Way, to its roundabout junction with the north/south section of Kempson Way.

Exemptions to the waiting restrictions allow a vehicle to wait for so long as is necessary to board or alight or to load and unload; for building, industrial or demolition works; for the maintenance of the road or its services; for blue badge holders; for emergency services, and to fulfil statutory duties.
