This document, prepared by Suffolk County Council (SCC), is the sixth infrastructure funding statement (IFS) published since the requirement to do so was confirmed in September 2019, when changes were made to the CIL Regulations, the Community Infrastructure Levy (Amendment) (England) (No. 2) Regulations 2019.

The first SCC IFS was published in December 2020 and covered the period 1st April 2019 to 31st March 2022. A new IFS has been published every year since.

An IFS provides a summary of all financial and non-financial developer contributions relating to section 106 Legal Agreements (s106), and the Community Infrastructure Levy (CIL) received by SCC for “*the reported year*”.

The information provided within this document relates to all the new activity in the reported year, for the period 1st April 2024 to 31st March 2025.

This statement also provides some examples of infrastructure projects delivered by SCC.

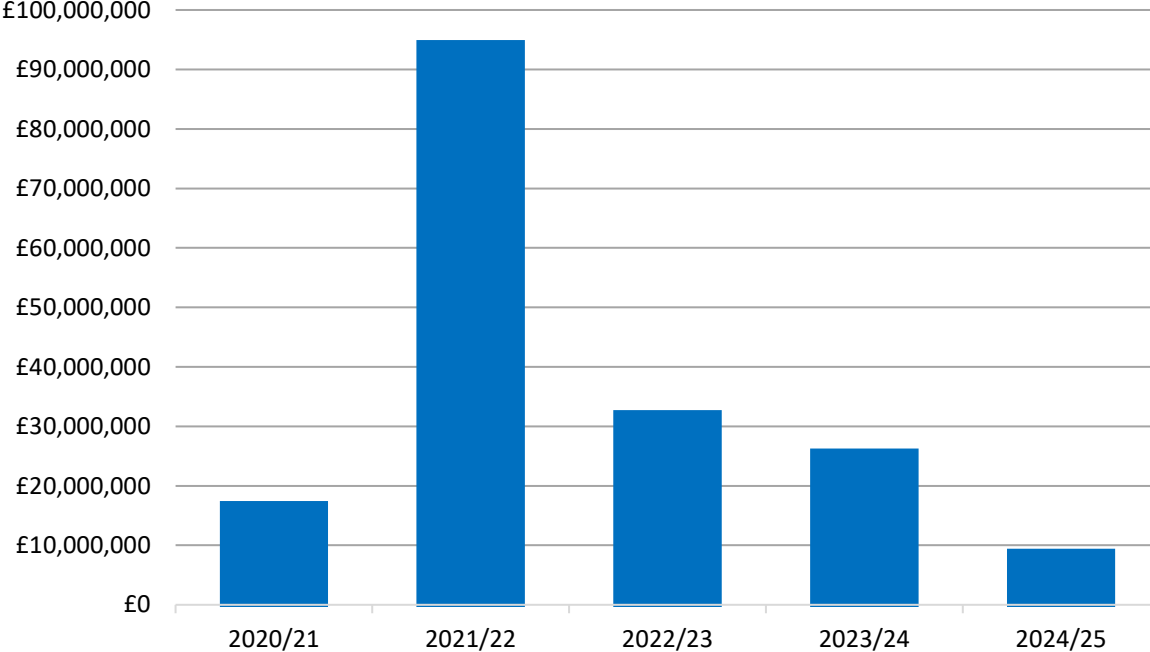

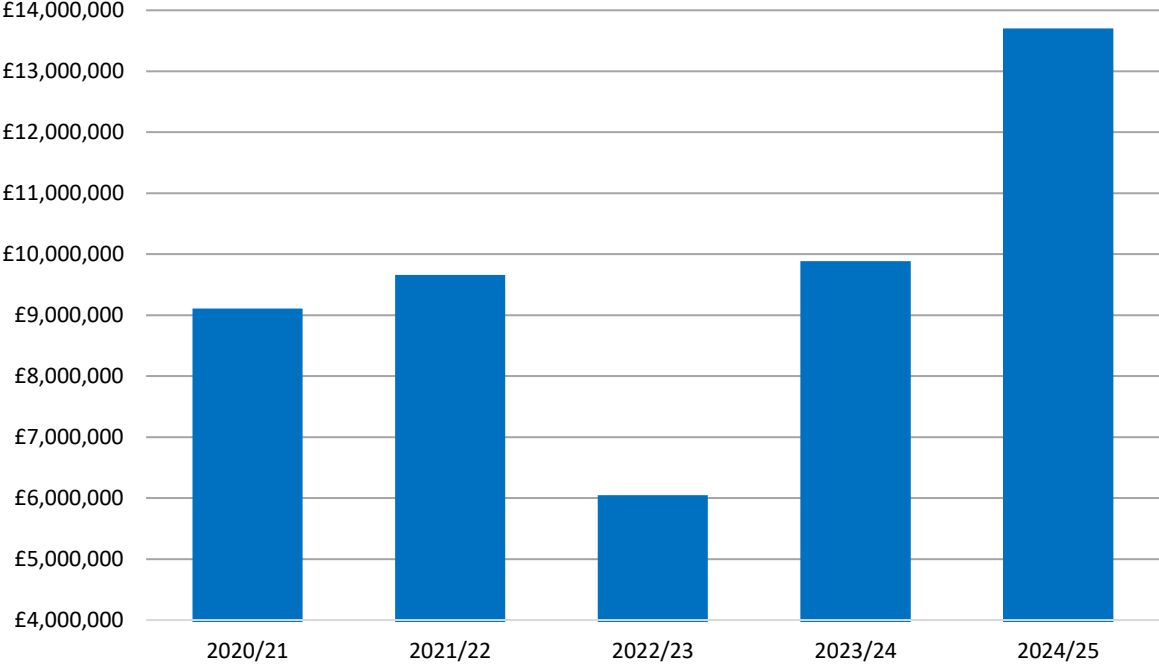

S106 Money Secured 2024/25 - £5,517,481.67

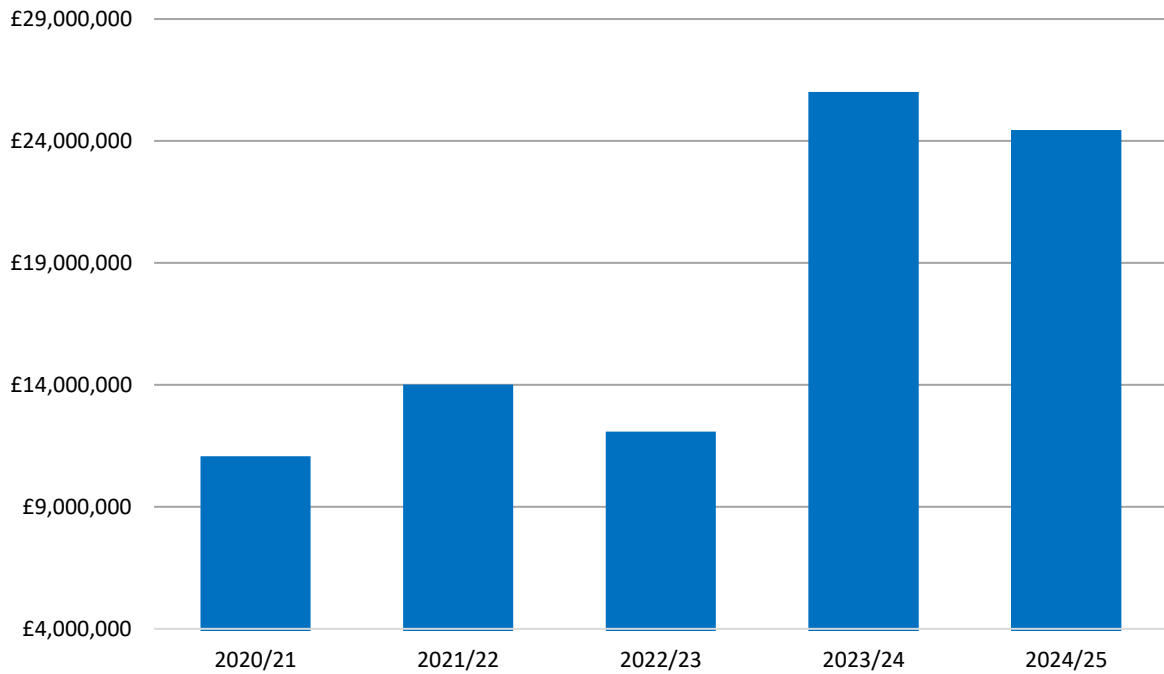


S106 Money Spent 2024/25 - £13,318,316.46

S106 Money Held 2024/25 - £62,451,026.95

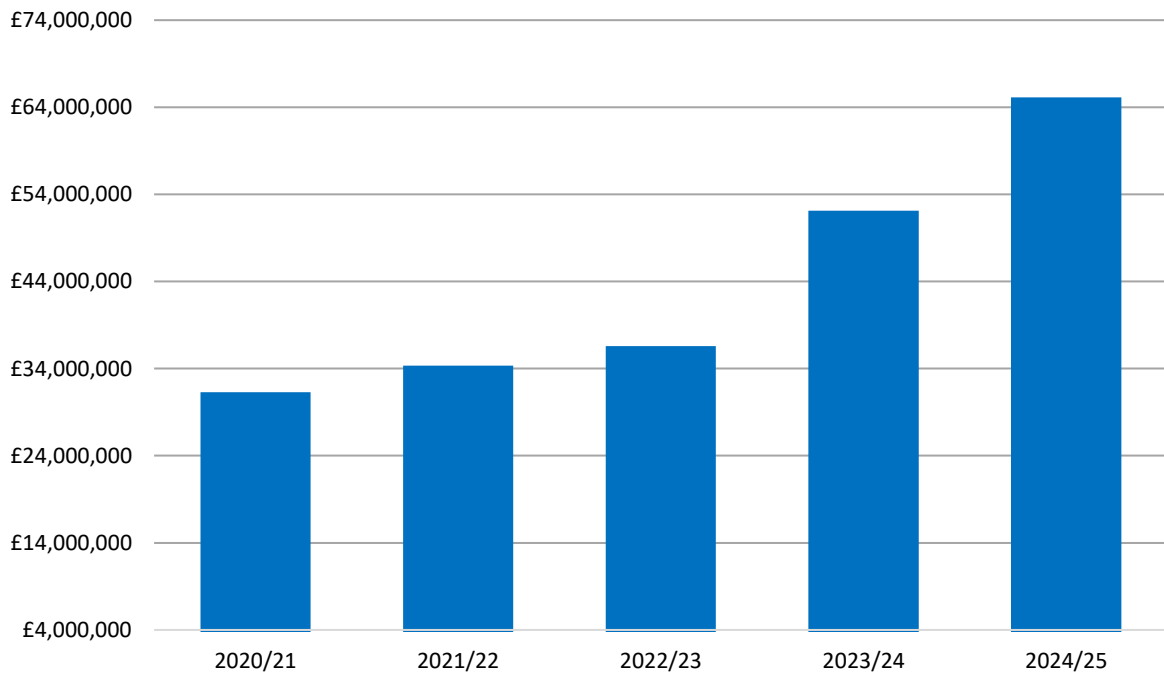

Introduction

1. Introduction

- 1.1 An infrastructure funding statement (IFS) is a statutory document that must be published each year by a “contribution receiving authority”. A contribution-receiving authority is any authority that issues a community infrastructure levy (CIL) liability notice or receives money or works in kind from a section 106 agreement.
- 1.2 The requirement to publish an IFS originated from the changes made to the CIL Regulations, The Community Infrastructure Levy (Amendment) (England) (No. 2) Regulations 2019 (<https://www.legislation.gov.uk/ukxi/2019/1103/regulation/9/made>) in September 2019.
- 1.3 The information that is published in an IFS differs from authority to authority. As SCC is not a CIL Charging Authority¹, its duty is to report on one of the three components set out in the regulations relating to section 106 contributions. However, this document also includes CIL funding that has been awarded to SCC from either Babergh District Council, East Suffolk Council or Mid Suffolk District Council.
- 1.4 Throughout this document, there are references to the following definitions:
 - **Secured** – the total amount of money, including monitoring fees, to be provided under any planning obligations which were entered into during the reported year. These contributions may not have been received, and if the planning applications are not implemented, they will never be received.
 - **Received and allocated** – the total amount of money, including monitoring fees, under any planning obligations which was received during the reported year. Contributions are assigned a local financial code that is unique to each contribution.
 - **Spent/Delivered** – the total amount of money (received under any planning obligations and including monitoring fees) that was spent by the authority (including transferring it to another person to spend). The contribution has been ‘drawn down’ by the service.

¹ *Suffolk County Council is the Community Infrastructure Levy ‘collecting authority’ as defined by CIL regulation 10 in respect of development for which it grants planning permission. Development that SCC as the Local Planning Authority for decision making include minerals, waste and education development which are not currently the subject of the districts CIL charging schedules and are considered zero (£) rated.*

- **Total amount of money** – the total amount of money (received under any planning obligations and including monitoring fees) that was allocated but not spent during the reported year for funding infrastructure.
- **Reported Year** – unless stated otherwise, this refers to the period 1st April 2024 – 31st March 2025.

Developer Contributions

2. Developer Contributions

2.1 Section 106 Agreements and Planning Obligations

2.1.1 Planning obligations can be secured through a section 106 agreement or a unilateral undertaking, depending on the nature of the development. A unilateral undertaking is a simplified version of a planning agreement and is entered into by the landowner and any other party with a legal interest in the development site. A section 106 agreement, on the other hand, is a more complex legal agreement that can be attached to a planning permission to mitigate the impacts of development. Both forms of obligation are often used to secure provision of, or contribution to, improved infrastructure such as new school facilities and libraries.

2.1.2 Planning obligations can only be sought where they meet three legal tests, as set out in Paragraph 58 of the NPPF:

- a) Necessary to make the development acceptable in planning terms;*
- b) Directly related to the development; and,*
- c) Fairly and reasonably related in scale and kind to the development*

2.1.3 The Council's expectations for s106 planning obligations are set out in the [Developers Guide to Infrastructure Contributions in Suffolk](#) [published August 2025]

2.2 Community Infrastructure Levy (CIL)

2.2.1 In contrast to s106 obligations, the Community Infrastructure Levy (CIL) is a fixed rate charge that district or borough councils can levy on new development in their area to off-set the impacts of additional homes and businesses on infrastructure such as health, schools, libraries, and waste facilities to support the delivery of sustainable growth. CIL monies can be used to fund the provision, improvement, replacement, operation, or maintenance of infrastructure to support the development of the area.

2.2.2 CIL rates are set out via a published Charging Schedule, and the following councils in Suffolk have implemented a CIL:

- Babergh District Council;
- East Suffolk Council; and
- Mid Suffolk District Council.

2.3 Relationship between local planning authorities and SCC for s106 and CIL

2.3.1 Where a local planning authority (LPA) has adopted a CIL Charging Schedule, the way in which infrastructure providers seek developer contributions changes. Projects which may have previously been funded by planning obligations in s106 agreements might now be funded via the CIL mechanism.

2.3.2 Except where charging authorities expect specific projects or types of infrastructure to be wholly or partly funded by CIL, SCC will continue to use s106 to seek planning obligations on behalf of its service areas to mitigate the impacts of development on local communities.

2.4 Section 278 Highway Agreements

2.4.1 Other legal agreements that can fund infrastructure are section 278 highway agreements (s278). These are legally binding agreements made under the Highways Act 1980 between SCC as the Local Highway Authority and developers; s278 agreements are required to secure alterations or improvements to the public highway.

2.4.2 It is recommended that local authorities should include s278 data in an IFS, and SCC has provided this information in Appendix 5. Notable schemes include: a widened access to Suffolk Retail Park in Ipswich, a new signalised junction to serve the Candlet Road development in Felixstowe, a pedestrian crossing in Stowupland and a new roundabout in Moreton Hall.

2.5 Borrowings

2.5.1 SCC, from time to time, borrows money to forward fund infrastructure projects. In those cases, SCC will look to retrospectively recover the infrastructure investment made through s106 and/or CIL bids.

2.5.2 Capital projects which use borrowings are also listed within SCC's Capital Programme². For every £10 million borrowed to support the capital programme, an additional £0.688 million of revenue funding is currently required annually to fund Minimum Revenue Provision (MRP) and interest costs.

S106 Contributions

3. S106 Contributions

3.1 For the reported year, SCC entered into 39 planning agreements³ as broken down below including five Unilateral Undertakings (in which SCC is not a party to the Deed but will receive a developer contribution). These include the following:

3.2 In certain circumstances, planning agreements are modified or varied; this change to a planning agreement is called a deed of variation (DoV). Of the 39 planning agreements signed in this reporting year, 7 were deeds of variation. It is important to note that the DoVs in this reported year are likely to relate to their original planning agreements secured in a previous reported year. It is also important to note that DoVs often have no new contributions for the County Council as they are often entered into to adjust non-County Council infrastructure such as matters of detail with the District or Borough's affordable housing or open space requirements.

3.3 The number of dwellings linked to planning agreements signed in this IFS totalled 1,055 dwellings (2,426 dwellings 2023/24).

3.4 The 7 deeds of variation signed during this reported year are listed in the table below, along with additional financial contributions secured therein.

- 3.5 Some of these contributions may have already been paid to SCC, but the majority will be calculated and paid at the later agreed trigger points (for example, on the commencement of the development build or, for larger sites, these payments may be phased) over the coming years.
- 3.6 Please see 'Appendix 1' and 'Appendix 2' - All-new s106 legal agreements entered into during the reported year 2024/25 and a full list of the contributions secured.
- 3.7 **£23,489,056.46** was received during the reported year. These contributions either fund part or all project costs and are allocated in accordance with the clauses of the legal agreements.
- 3.8 A large proportion of the funding received will fund new schools and school expansions to accommodate the population growth. Funding also included contributions for transport and travel, waste, and library projects. A significant sum is also attributed to payments from Sizewell C Nuclear Power Station.
- 3.9 On 8 October 2021 East Suffolk Council, Suffolk County Council and NNB Generation Company (SZC) Limited entered into a Deed of Obligation (DoO) in relation to the Sizewell C. The DoO can be viewed at the following website: [Deed of Obligation](#)
- 3.10 The Sizewell C DoO is not a section 106 agreement but for the purposes of the IFS it is included in the reports. A significant portion of the funding received in this IFS year is from Sizewell C which can be identified in Appendix 4, reference EN010012 in the parish of Leiston.
- 3.11 As soon as a contribution is received by SCC, it is allocated to the relevant service and project as described in the s106 agreement. Therefore, for the

period up until and including 31st March 2025, there is no received money that has not been allocated, i.e., £0.

3.12 The table below provides a summary of the non-monetary contributions that were secured through s106 agreements in the reported year 2024/25.

3.15 **£23,489,056.46** of s106 funding was received during the reported year. See Appendix 4 for breakdown.

3.16 SCC did not use any developer contributions to repay borrowing or interest in the IFS year. SCC finances the capital programme as a whole by applying the available sources of funding and use borrowing to bridge any gap each year. If a project is to be financed by a developer contribution but this has not yet been

received, we would apply another financing source and swap this around to finance something else once the developer contribution is received in a later year.

- 3.17 No specific loans were taken out to cover spend incurred on a project which has not yet received its developer contribution and therefore do not calculate any interest either.
- 3.18 Since September 2019 SCC has charged a monitoring fee on planning obligations. From 1st January 2025 SCC charge a minimum of **£519** for each separate trigger point in a planning obligation towards administration costs. The fee is based upon the occurrence of triggers for compliance of a planning obligation rather than each obligation individually. The monitoring fee is to be paid on completion of the s106 legal deed, as SCC must start administration activities from that point onwards.
- 3.19 **£63,897.25** in monitoring fees was spent during the reported year. The monitoring fee will be drawn down outside of this IFS year and spent on the recently procured monitoring software.
- 3.20 The total amount which has been received and allocated (in any year) (up to 31st March 2025) but will be spent in upcoming years is **£62,451,026.96**. S106 funding is closely monitored and robustly managed via a vigorous internal sign-off mechanism to ensure that it is used for the purpose identified within the original agreement.
- 3.21 The reason the above figure is significant is not only due to Sizewell C, but that many contributions have a period of 10 years for SCC to spend the money. Larger infrastructure projects such as school expansions or new schools are often linked to other developments, and these developments will not secure all s106 contributions at the same time as the first. The infrastructure projects themselves may only be delivered when a substantial quantum of growth has arisen.

3.22 This statement provides information on the planning obligations secured during the reported year, based on the date that the planning agreements have been signed. It is important to bear in mind that where there are planning appeals progressing on sites that have secured s106 agreements, these appeals may affect the planning obligations for instance if an appeal is dismissed after the IFS is published, in which case the agreement will be removed from the SCC website and adjusted for in the IFS.

4. Infrastructure projects delivered or being delivered by SCC

This section provides some examples of the infrastructure projects delivered by SCC during the reported year or recently.

4.1 Education projects

4.1.1 Martlesham Primary Academy Refurbishment

A range of refurbishment works at Martlesham Primary completed in March 2025, including a brand-new classroom block for Year 6 pupils with a cloakroom, toilet facilities and plant room.

The refurbishments also included the redecoration of another classroom to be used as new SEND provision.

The project was awarded £615,240 in CIL funding by East Suffolk Council in September 2021 as well as a further £615,000 in September 2022 (Total project cost £1,230,000).

4.2 Libraries projects

4.2.1 Beck Row – Pop-up Library

Since June 2024 Beck Row has benefitted from a new weekly pop-up library service in the Parish Hub. Users can use the new service to reserve and borrow books, as well as accessing computer facilities. Additionally, the service provides activity sessions for children.

The project has received £6,607 of S106 funding so far.

4.3 PRow projects

4.3.1 Brantham – FP1 Resurfacing

This project improves the existing Public Rights of Way network by providing a new surface for a section of FP1 in Brantham. The new path also provides safe access to the Rights of Way Network for circa 65 new dwellings currently being built out adjacent to the footpath. Works were completed in February 2025.

The resurfacing was financed with £10,512 of S106 funding.

4.3.2 Thurston – FP7 works

This project improves the existing Public Rights of Way network by replacing the footpath surface, which was previously unmade earth and therefore unsafe and inaccessible in wet conditions. The project was completed in April 2025.

The works were funded with £24,222 of S106 funding.

4.4 Public Transport Projects

4.4.1 Bus Stop Improvements, Witnesham

Various bus infrastructure improvements were completed around the village of Witnesham in April 2025. 2 bus stops were improved with new shelters and DDA kerbing, with additional hardstanding provided at the Village Sign stop. These upgrades will provide improved service for passengers travelling between Ipswich and Framlingham.

The works were completed with £15,949 of S106 funding, which will be drawn down in the next IFS year.

4.5 Highways Projects

4.5.1 Suffolk One Footway, Ipswich

A new footway connecting the A1214 (London Road) to Scrivener Drive and One Sixth Form College was completed in Autumn 2024. The footway forms part of a wider network of walking and cycling connections between Ipswich/Suffolk One and the new Wolsey Grange housing development to the north of the A1214.

S106 funding for the project totalled £50,000.

5. Community Infrastructure Levy

5.1 Although SCC is not a CIL charging authority, CIL funding is received for some infrastructure projects following successful bids to the local planning authorities (LPAs), who are CIL Charging Authorities.

5.2 It is important for SCC to receive CIL funding to deliver the infrastructure necessary to mitigate development in the districts. The consequence of SCC not receiving CIL funding would mean projects not being delivered, or where other funding (historic s106 contributions) is primarily delivering the project, SCC would have to borrow money to pay for the funding gap. For every £10m borrowed, the cost of borrowing is currently estimated at £688k per annum for 30 years, up from the previous figure of £571k.

5.3 SCC provides details below of the successful awarding of CIL funding. This includes collection and subsequent spend.
