

Motion: Proposed by Councillor Sarah Adams and seconded by Councillor Peter Gardiner. "The serious health impacts of pollution have been described by Defra (2018), DoH (2011), and WHO (2013) and we know that there are longstanding illegal levels of pollution in parts of our county.

In light of this, the council will immediately direct appropriate resources and discharge their obligation under Part IV of the Environment Act to work constructively with Ipswich Borough Council, East Suffolk Council, Mid Suffolk District Council, Babergh District Council and West Suffolk Council, to develop an Air Quality Action Plan (AQAP) as required by section 2.69 of Local Air Quality Management Technical Guidance (LAQM TG(16)) (Feb 2018), and reduce levels of pollution to legal levels within 3 years."
