7. Applications to vote by emergency proxy at this election on grounds of physical incapacity or for work/service reasons must reach the Electoral Registration Officer at West Suffolk House, Western Way, Bury St Edmunds, IP33 3YU by **5 pm on Thursday, 6th May 2021**. To apply, the person must have become aware that they cannot go to the polling station in person after **5 pm on Tuesday, 27th April 2021**.
