

## NOTICE OF PROPOSAL TO MODIFY DEFINITIVE MAP ORDER

### WILDLIFE AND COUNTRYSIDE ACT 1981

Notice is hereby given pursuant to paragraph 8(2) of Schedule 15 to the Wildlife and Countryside Act 1981 that the Inspector appointed by the Secretary of State for Environment, Food and Rural Affairs to determine the Suffolk County Council Definitive Map & Statement for the Parish of Newmarket in the District of Forest Heath, Suffolk County Council (Parish of Newmarket) Modification Order 2018 proposes to modify the Order by providing for the following modifications:

- Delete all references to "*footpath*" and insert "*restricted byway*".
- Delete "*a gate at*" from the second and third lines in Part II of the Order Schedule.
- Delete "*11 metres to a gate and a*" from the third line in Part II of the Order Schedule and insert "*approximately 18 metres to the*".
- Delete the final three lines of Part II of the Order Schedule and insert "*Width: 4.2 metres (14 feet)*".
- Include the notation for a restricted byway on the Order Map rather than the notation for a footpath and amend the map key accordingly.
- Show the restricted byway by means of a revised alignment towards its northwestern end on the Order Map.

A copy of the Order as submitted and a copy of the Order showing the proposed modification together with the Inspector's Order decision dated 23 May 2022 have been deposited at Newmarket Library, 1a the Guineas, Newmarket CB8 8EQ and may be inspected free of charge during normal working hours.

This Order is made by Suffolk County Council under section 53(2)(b) of the Wildlife and Countryside Act 1981 ("the Act"), because it appears to that authority that the Definitive Map and Statement for the parish of Newmarket in the district of Forest Heath require modification in consequence of the occurrence of an event specified in sections 53(3)(c)(i) namely, the discovery by the authority of evidence which shows that a ~~footpath~~, which is not shown in the map and statement subsists or is reasonably alleged to subsist. *restricted by way*

The authority has consulted with every local authority whose area includes the land to which the Order relates. The Suffolk County Council hereby order that:

1. For the purpose of this Order the relevant date is 1 October 2018.
2. The Definitive Map and Statement for the parish of Newmarket in the district of Forest Heath shall be modified as described in Part I and Part II of the Schedule and shown on the map attached to the Order.
3. This Order shall take effect on the date it is confirmed and may be cited as the Suffolk County Council (Parish of Newmarket) Modification Order 2018.

## SCHEDULE

### Part I: Modification of Definitive Map

#### Description of ~~footpath~~ <sup>residual by way</sup> to be added

There shall be added to the Definitive Map for the parish of Newmarket a ~~footpath~~ <sup>residual by way</sup> from a point at Ordnance Survey grid reference 56474,26295 to a point at Ordnance Survey grid reference 56472,26297 as shown on the attached map.

### Part II: Modification of Definitive Statement

#### Particulars of ~~footpath~~ <sup>residual by way</sup> to be added

There shall be added to the Definitive Statement for Newmarket the following particulars:

#### Newmarket ~~Footpath~~ <sup>Residual By way</sup> 30

Commencing at a junction with Cricket Field Road (Point A) at Ordnance Survey Grid Reference (OSGR) 56474,26295 and progressing in a north westerly direction along a path for 17 metres to ~~a gate at~~ OSGR 56472,26296; continuing across railway level crossing for ~~11 metres to a gate and a~~ <sup>approximately 18</sup> ~~the~~ junction with Granary Road (Point B) at OSGR 56472,26297.

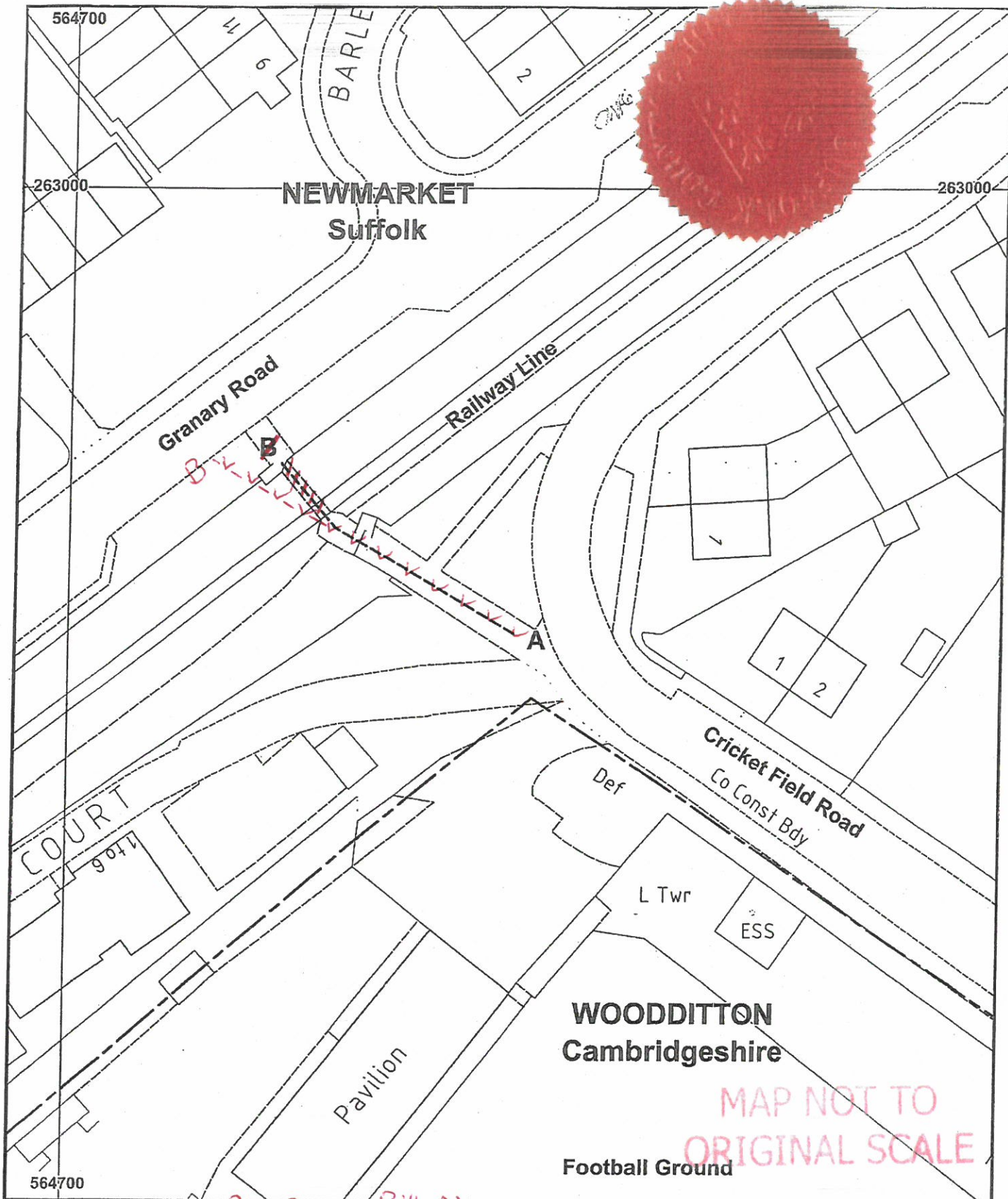
Width: ~~1.2 metres~~ <sup>4.2 metres (14 feet).</sup>
