HOW TO USE THIS READY RECKONER

Select your family circumstances from the column on the left. Then select your family's total weekly income from the top row. This will show you how much you will have to pay towards the cost of any work done to your house before you will receive grant aid. You may be eligible for grant aid towards the balance, up to the maximum amount available, subject to approval.

EXAMPLES

Single Pensioner with an income of £175 per week will need to pay the first £177 of any grant approved work. Pensioner couple with a joint income of £325 per week will need to pay the first £3, 661 of any grant approved work.
