

**SUFFOLK COUNTY COUNCIL (PARISHES OF ASHBY, BLUNDESTON, CORTON,  
HERRINGFLEET, LOUND, OULTON AND SOMERLEYTON) (VARIOUS ROADS)  
(40 MPH SPEED LIMIT AND REVOCATION) ORDER 202-**

Suffolk County Council proposes to make the above order for Oulton Division under Section 84 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, the effect of which would be to reduce the speed limit from national speed limit to 40 mph on:

- Part of Back Lane in the Parish of Lound
- Part of Blocka Road in the Parishes of Ashby and Herringfleet
- Part of Blundeston Road in the Parish of Somerleyton
- Somerleyton Road in the Parish of Blundeston
- Border Lane in the Parishes of Ashby and Lound
- Browston Lane in the Parishes of Ashby and Lound
- Part of Church Lane in the Parish of Lound
- Part of Church Road in the Parish of Blundeston
- Part of Dorking Road in the Parish of Lound
- Flixton Road in the Parishes of Blundeston and Lound
- Green Lane in the Parish of Somerleyton
- Part of Hall Road (C905) in the Parish of Blundeston
- Hall Road (6U3001) in the Parish of Lound
- Part of Jay Lane in the Parish of Lound
- Part of Lound Road in the Parish of Blundeston
- Market Lane (C903) in the Parishes of Ashby and Somerleyton
- Part of Market Lane (6U3009) in the Parish of Blundeston
- Parts of Oulton Road and Park Hill in the Parishes of Blundeston, Oulton and Corton
- Rackhams Corner and Gorleston Road in the Parishes of Blundeston and Corton
- Yarmouth Road in the Parish of Lound
