## Suffolk County Council's Renewable Energy Fund

Businesses are increasingly looking to reduce their operating costs, increase their energy resilience and reduce their carbon footprint. As a result, solar panels have become a popular choice.

An increasingly attractive option to many, where the initial investment capital is hard to access, are power purchase agreements. This is a contract for generating and selling energy. Suffolk County Council's Renewable Energy Fund will provide the capital cost for the solar installation and will sell the energy generated back to you at a cheaper rate than your current electricity supplier, reducing your costs and your carbon emissions.

If you're an organisation in Suffolk with a large demand for electricity and a large roof area then a power purchase agreement might be the solution for you.
