


- **1.0** Suffolk County Council as a Lead Local Flood Authority (LLFA) has determined that in accordance with criteria, it considered it necessary or appropriate to carry out an investigation into this flood event in accordance with Section 19 (1) of the Flood and Water Management Act 2010, and in accordance with Section 19 (2) of the Flood and Water Management Act 2010, to publish the results and notify the relevant risk management authorities (RMAs).

- 2.1 Location: Langer Road, Felixstowe
- 2.2 Flood Event Date: 5 June 2015
- 2.3 Reported to SCC Date: 20 July 2015
- 2.4 Investigation Commencement Date: 27 July 2015
- 2.5 Criteria for investigation:

Criteria for an investigation (as per Appendix D of the Suffolk Flood Risk Management Strategy):		
There was a risk to life as a result of flooding?		
Internal flooding of one property (domestic or business) has been experienced on more than one occasion?	~	
Internal flooding of five properties has been experienced during one single flood incident		
Where a major transport route was closed for more than 10 hours as a result of flooding		
Critical infrastructure was affected by flooding		
There is ambiguity surrounding the source or responsibility of a flood incident		







- 2.6 Grid Reference: 629352, 233383
- **2.7 Extent of flooding:** It is indicated that 4 domestic properties flooded internally affecting the main living areas, garages and gardens. The public highway partially flooded for approx. 50m to an approx. depth 200mm. The Anglian Water surface water drainage system surcharged.
- **2.8 Effect of flooding:** Properties internally flooded to a depth of 150mm and public highway flooded to 150-200mm.
- **2.9 History:** Residents have shared records of flooding in this location since 2007. SCC has records of Highway flooding since 2011.
- 2.10 Flooding Source: Surface water and ground water.
- 2.11 Causes:
 - Possible exceedance of design capacity of surface water drainage system. i.e. SCC Highway drainage & Anglian Water surface water system
 - Blockages of some of SCC Highways & Anglian Water assets
 - High water table under Langer Rd area
 - The properties are located within an area mapped as being at risk of pluvial flooding.





- Vegetation washed down stream and blocked trash screens in Langer Park watercourse
- Blockages at several locations along the Langer Park watercourse
- **2.12** Additional Information: A large volume abstraction point is operated by a business in Dock Rd and high minor aquifer is located under the Langer Rd area.

3.0 Risk Management Authority with Relevant Flood Risk Function

- Anglian Water
- Suffolk County Council
- Suffolk Coastal District Council

3.1 Functions:

- Anglian Water (Surface water drainage maintenance & asset owner)
- Suffolk County Council (Public highway maintenance & asset owner)
- Suffolk Coastal District Council (Riparian land owner)

4.0 Recommendations:

- 1. Maintenance schedule of Langer Park watercourse to be reviewed and enhanced if required by Suffolk Coastal District Council.
- 2. Suffolk County Council surface water drainage system design capacity to be reviewed
- 3. Anglian Water to assess the design of the trash screen, and redesign if appropriate. Flood mitigation, resilience recovery measures to be considered by all affected property owners.
- 4. Property owners look to flood resilience measures to mitigate the ground water flood risk.
