

SUFFOLK COUNTY COUNCIL (DISTRICT OF SUFFOLK COASTAL) (STOPPING, WAITING AND LOADING PROHIBITIONS AND RESTRICTIONS AND ON-STREET PARKING PLACES) (MAP-BASED) ORDER 2019 (BOROUGH OF IPSWICH) (WESTERFIELD ROAD) (B1077) (PROHIBITION OF WAITING AND LOADING) (VARIATION NO.23) ORDER 202-

Suffolk County Council proposes to make the above order under Sections 1(1) and (2), 2(1) to (3), 4(2) and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984, as amended, which would incorporate revision 0 of Map Tile GC124 into the above-named 2019 Order. The effect of this would be to introduce:

‘No Waiting At Any Time’ and ‘No Loading and Unloading At Any Time’ on Westerfield Road (B1077) on:

- the north side of the northbound carriageway in a northerly direction for a total distance of 32.5 metres starting from the end of yellow hatching lineage at the Railway Level Crossing on the north side;
- the north side of the southbound carriageway, in a northerly direction, for a total distance of 46.1 metres, starting from the end of the existing horizontal white stop line at the Railway Level Crossing on the north side;
- the south side of the northbound carriageway, in a southerly direction, for a total distance of 42 metres starting from the start of the existing white stop line at the Railway Level Crossing on the south side; and
- the south side of the southbound carriageway, in a southerly direction, for a total distance of 42 metres starting from the end of yellow hatching lineage at the Railway Level Crossing on the south side.

Exemptions to the waiting restrictions allow a vehicle to wait for so long as is necessary to board or alight; for emergency services; for the maintenance of the road or its services; and for fulfilling statutory duties. Post office vehicles are also exempt. Blue-badge holders are not exempt. For the Loading/Unloading restriction, these exemptions will not follow.
